What does this policy cover?

This Privacy Policy applies only to your use of our site. Our site may contain links to other websites. How long do we keep your personal data?

- Projects – specifically defined for each project and held within the processing activity record
- Suppliers (non-project) –as per current legislation (7yrs)

How and where we store your data

We only keep your personal data for as long as we need to in order to use it as described above in section 6, and/or for as long as we have your permission to keep it.

Data security is very important to us, and to protect your data we have taken suitable measures to safeguard and secure data collected through our site.

Do we share your data?

We never share your data with third party marketing companies.
